Rules of Court - Covid 19 Contingency

The Chief Justice has today published the following:

- Notice of Extension of the Supreme Court (Covid-19 Contingency) Rules 2020
- Notice of Extension of the Magistrates' Court (Covid-19 Contingency) Rules 2020

Both sets of rules have been extended up to and including 5 June 2020, both the Supreme Court Registry and Magistrates' Court counters remain closed. However, we are constantly reviewing matters and the Chief Justice will reopen our counters in line with the reopening of Her Majesty's Government of Gibraltar's public counters.

We have undertaken risk assessments and are seeking further advice from Public Health Gibraltar. In the first instance it is intended to list those matters that have been vacated by virtue of the operation of the Rules. This may happen even if the counters remain closed and the Rules continue in operation.

The general stay on civil actions will continue to operate until 7 days after the Registry has fully re-opened. In the event that the Rules cease to have effect, upon expiry or prior determination by the Chief Justice, the 7 day extension of the stay will also apply.
